\* Any member who chooses to purchase an annual cart pass, personal cart storage, or off-course personal cart storage is required to sign and return a cart storage / usage agreement.

All memberships will become delinquent January 1st, 2018 unless 2018 membership is paid in full or monthly payment plan option is selected. Privilege of participation will be suspended in the event that payment is not received.

Golf memberships will receive a one year membership to the GHIN handicap program and annual range pass. This includes all monthly payment memberships.

Memberships in the Oakland Golf Club are on a yearly basis beginning January 1st of each year and continuing through December 31st of same year. A new member is one who has not held an Oakland Golf Club membership for the previous 5 years. All golf members (except college & student memberships) are required to purchase a certificate of participation. This is a one-time charge of \$25.00 making all golf members eligible to vote at the annual meeting, and to serve on the board of directors. Current holders of stock or participation certificates need not purchase an additional certificate.

Membership dues and charges become delinquent after the 15th of each month. All accounts will be charged to credit card on file the 15th of each month unless alternative payment plans have been arranged w/ manager and treasurer of the Board of Directors. After 30 days, interest will be charged on the member's account at the rate of 1 ½ % per month. If a member becomes 60 days past due, the member loses all Club privileges and their account may be turned over to a collection agency.
